## Study British communism from party discipline...

British Online Archives updated collection, *Democratic Centralism during the Cold War, 1943-1991* is drawn from the papers of the Communist Party of Great Britain's (CPGB)'s ruling Executive Committee (EC).

The Executive Committee met on a bi-monthly basis to carry out decisions made at the annual National Congress.



This collection is one of many CPGB resources hosted on the British Online Archives website.

Although formally subordinate to Congress according to the CPGB constitution, the Executive Committee, through its appointment of committee members and enforcement of democratic centralism, operated the internal apparatus of the party machine and dealt with dissenting members in no uncertain terms.



It was decided to send telegrams of congratulation to the successful candidates in the local Elections.

1: POLITICAL SITUATION.

- Comrade Mahon made the report and replied to the discussion after fifteen comrades had spoken. The report and proposals were ENNORED.

# The collection contains over 28,000 unique images.

Content from meetings of the Executive Committee largely include official minutes and agendas, handwritten personal notes by attending individuals, and reports delivered to the EC on various important topics.

As such, the collection offers insights into everything from Cold War tensions and decolonisation, to internal power struggles and the expulsion of CPGB members.

### CAMPAIGN AGAINST CRUISE

In the next few weeks and months a great mobilisation of millions of people against the siting of Cruise missiles needs to take place. A high point of this mobilisation will be the October 22nd demonstration in London, organised by the CND.
